Between 16 April 2020 and 25 January 2023 the Registered Certifier conducted 151 swimming pool compliance inspections by way of a video conference call, rather than being personally onsite to inspect those swimming pools.

The Registered Certifier misled Fair Trading investigators as to the dates on which he had commenced and ceased conducting such video inspections.

On at least eleven (11) occasions between 2020 and 2022, the Registered Certifier contravened clause 21(6) of the *Swimming Pools Regulation 2018* (SP Regulation).

On at least four (4) occasions in 2021, the Registered Certifier provided misinformation to former clients and misled them in relation to the law relating to certification work.

Between April 2020 and January 2022, the Registered Certifier contravened sections 307A to 307C and 192E of the *Crimes Act 1900 NSW* (**Crimes Act**). The conduct in relation to those offences related to:

- 1. Providing false information on an application for accreditation as a certifier;
- 2. Creating and dealing with false written notices of non-compliance and non-compliance certificates;
- 3. Fraudulently accepting payment from a client after holding out that he was able to apply for an extension to comply with section 22E(4) of the Swimming Pools Act 1992 (NSW)(SP Act), where no such extension is legally available.
