# When should this form be lodged?

- This form is used to register rule amendments and other special resolutions passed by the co-operative.
- This form should be lodged within **28 days** of passing the special resolution, except for a special resolution to wind up a co-operative which must be lodged within 7 days. Late fees will apply for late lodgement.
- Where the special resolution relates to a rule amendment:

   section 60 of the *Co-operatives National Law (NSW)* requires pre-approval of certain rules. Information in relation to the rules that require pre-approval can be found on the Fair Trading website.

### Fees

  - \$36.00 per special resolution up to a maximum of \$238.00 where no rule amendment has occurred.

If lodged more than 1 month after the due date: \$126.00 The late fee (if applicable) must be paid at the time of application.
