THINGS TO KNOW BEFORE STARTING

Before changing its name by special resolution, a co-operative should provide details of the proposed new name to Registry and Accreditation to determine whether the name is able to be approved.

The name you propose may not be approved because it is deemed unsuitable or similar or identical to an existing name. To check to see if your name already exists or is similar you can search <u>ASIC's organisation and business names register</u>.

The name of a co-operative must include the word `Co-operative' or the abbreviation `Co-op' and must end in the word `Limited' or the abbreviation `Ltd'.

The rules of the co-operative that include the name will also need to be changed. A Form C10 - Application for Register Rule Amendment(s) / Special Resolution(s) to register changes to the rules will need to accompany this application.

How to complete this form

- Please use a blue or black pen and print clearly using block letters.
- · All parts of the form and the contact details must be completed.

Fees

• The application fee is \$281.00

The fee must be paid at the time of application. There is no GST payable.

How to lodge

- **Step 4** Attach a copy of the receipt to the form.

Not providing this information may result in delays in processing your form.

Alternatively, if you intend to pay by cheque or money order this can be done in person at any Service NSW Centre.

Cheques or money orders should be made payable to NSW Fair Trading.

What happens when you lodge your application

- The application will be reviewed. You will be notified in writing if further information is required.
- If your application is approved, you will receive a certificate of registration on change of name.
- If your application is refused, you will receive written notification of the reasons.
- If any change occurs in the information you have provided in this form, you must notify NSW Fair Trading as soon as possible.


