












Figure 1: Average Adjudication Fee Expressed as a % of Average Amount (by Claim Range for this Quarter)





⁽³⁾ Average Claimant share expressed as a percentage of the ANA Fee.




Figure 4: Parties Share of ANA Fees expressed as a % of Average ANA Fees (by Claim Range for this Quarter)
