Key questions to ask funeral providers:

- What activities or products will you allow me to provide or organise myself?
- Can I easily customise a package, or add or remove components?
- Are there additional costs that will need to be paid? (e.g. burial/cremation costs)
- Will you provide an itemised quote and any terms and conditions, specifying any fees and charges that may be payable? Do you charge to provide a quote?
- Will I be charged a fee if I change funeral providers?
- Do you take commissions from your suppliers and is this specified?
- Is your business a part of a funeral director association?

Legal requirements of funeral directors in NSW:

- All funeral directors need to clearly show information about the goods and services they offer for burial and cremations, including a price list
- The price list must include prices for: transport of the body before burial or cremation; storage of the body at a mortuary or holding room; hire of a refrigeration plate; each type of coffin, casket or shroud supplied or the price range of all coffins, caskets or shrouds supplied; care and preparation of the body before burial or cremation; viewing of the body prior to burial or cremation; arrangement and conduct of a funeral service (including venue hire); burial or cremation of the body

11. Does the itemised quote you have received include prices for the following items

The price of the particular goods and services that will be supplied to you

The cost of any third party or additional costs (disbursements) that will be payable by you

The total amount payable under the agreement

Legal requirements of funeral directors in NSW:

- · An itemised quote containing the above information must be provided before an agreement (contract) is signed.
